Journey to Salesforce Voucher Sweepstakes Official Sweepstakes Rules

1. NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED.

2. **AGREEMENT TO OFFICIAL RULES:** Participation in the Sweepstakes constitutes entrant's full and unconditional acceptance of these official rules ("Official Rules") and the decisions of the judges, administrators and Sponsor, which are final and binding in all aspects.

4. ELIGIBILITY: The Sweepstakes is open to individuals who reside in the United States (incl. D.C.) or Canada (excl. (collectively, the above steps are one "Entry")

All applicable Trailmixes must be completed during a Monthly Entry Period, and entries submitted during one Monthly Entry Period will not carry over to subsequent Monthly Entry Periods.

Limit of one (1) Entry per person during the Sweepstakes Entry Period, regardless of the method of entry. Entry information becomes the property of Sponsor and will not be acknowledged or returned.
