

## Journey to Salesforce Sweepstakes 2024 to 2025

Official Sweepstakes Rules

- 1. NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING, VOID WHERE PROHIBITED.
- 2. **AGREEMENT TO OFFICIAL RULES:** Participation in the Sweepstakes constitutes entrant's full and unconditional acceptance of these official rules ("Official Rules") and the decisions of the judges, administrators and Sponsor, which are final and binding in all aspects.
- 3. **ENTRY PERIOD:** The Journey to Salesforce Sweepstakes 2024 to 2025 ("Sweepstakes" or "J2S Sweepstakes") sponsored by Salesforce.com India Private Limited ("Sponsor") begins on 1 July 2024 at 12:00am and ends on 31 January 2025 at 11.59pm ("Entry Period"). Sponsor's computer will be the official clock for the Sweepstakes. All entries must be received during the Entry Period to be eligible to enter the Sweepstakes or win a prize. All times in these Official Rules are India Standard Time (IST). The Sweepstakes Entry Period will be divided into monthly entry periods (each a "Monthly Entry Period") as specified in the table below.

4. **ELIGIBILITY:** The Sweepstakes is open to individuals who reside in India, US (incl. D.C.) and Canada (excl. Quebec and Manitoba) ("Eligibility Area") and who (i) are 18 years of age or older or who have reached the age of majority in their jurisdiction of residence as of the date of entry, and (ii) are legal residents of the Eligibility Area. To be eligible, participants must

also (i) have an active Salesforce Trailhead account; (ii) sign up to Journey to Salesforce via trailhead.salesforce.com and (ii) have not previously completed the Journey to Salesforce Trailhead courses listed below in Section 5 of these Official Rules. Within the Eligibility Area, the Prize opportunities are dependent on a participant's country of residence (either: (a) India; or (b) US or Canada), as described in Section 6 below. Employees, contractors, consultants, officers, directors and agents (and their immediate families and household members regardless of where they live), or members of the same households, whether related or not, of Sponsor, its parent, divisions, subsidiaries, agents, promotional partners, advertising/promotion agencies, and prize suppliers ("Sweepstakes Entities") are not eligible to participate in the Sweepstakes or win any prize. Employees or officials of any government entity are not eligible to participate or win a prize. If you enter this Sweepstakes on behalf of a company, you represent and warrant that you are an authorized agent with the authority to enter on its behalf and bind said company. Failure to meet the eligibility requirements will result in an entry being invalid and forfeiture of any prize. ## 5. **TO ENTER:**

- (i) To enter to potentially win a Drink Bottle, eligible participants must, during a Monthly Entry Period:
  - (a) log in to Salesforce's Journey to Salesforce Trailhead via <a href="mailto:trailhead.salesforce.com">trailhead.salesforce.com</a>; and
  - (b) In order to be eligible to win a Drink Bottle (defined below), enroll in and complete the <u>Journey to Salesforce</u> Trailhead Trailmix 1 badge.
- (ii) To enter to potentially win a T-shirt, eligible participants must, during a Monthly Entry Period:

  (c) in addition to (a) and (b) above, also enroll in and complete the <u>Journey to Salesforce</u>
  - Trailhead Trailmix 2 and Trailmix 3 badges.
- (iii) To enter to potentially win a Voucher, eligible participants must, during a Monthly Entry Period:
  - (d) in addition to (a), (b) and (c) above, also enroll in and complete the <u>Journey to Salesforce</u> Trailmead Trailmix 4a or Trailmix 4b badges.

All applicable Trailmixes must be completed during a Monthly Entry Period, and entries submitted during one Monthly Entry Period will carry over to subsequent Monthly Entry Periods. Limit of one (1) entry per person during the Sweepstakes Entry Period, regardless of the method of entry. Entry information becomes the property of Sponsor and will not be acknowledged or returned. Entries will be disqualified if they are late, incomplete and/or in excess of the stated entry limits. Any entries attempted through the use of agencies or robotic,

repetitive, automatic, programmed or similar methods will be void. Limit one (1) first prize, one (1) second prize, and one (1) runner up prize per entrant.

## 6. **PRIZE AND PRIZE VALUE**:

- (a) Prizes for participants residing in India: Ninety (90) per month, Six hundred and thirty (630) first prize winner(s) in total, will each receive one (1) Salesforce certification voucher applicable for JS1 or PD1 exams ("Voucher"). The approximate retail value ("ARV") of each voucher prize is \$200. Hundred (100) winners per month, seven hundred (700) second prize winners in total will each receive one (1) Salesforce branded t-shirt ("T-shirt"). The ARV of each T-shirt is \$20. One hundred and fifty (150) per month, one thousand and fifty (1050) runner up winners in total, will each receive one (1) Salesforce-branded swag drink bottle ("Drink Bottle"). The ARV of each runner up prize is \$12. Total ARV of all prizes for India is \$152,600. All currency listed in these Official Rules is in USD.
- (b) Prizes for participants residing in either US (incl D.C.) or Canada (excl Quebec and Manitoba): Twenty Five (25) per month, one hundred and seventy five (175) first prize winner(s) in total, will each receive one (1) Salesforce certification voucher applicable for JS1 or PD1 exams ("Voucher"). The approximate retail value ("ARV") of each Voucher prize is \$200. One hundred (100) winners per month, seven hundred (700) second prize winners in total, will each receive one (1) Salesforce branded t-shirt ("T-shirt"). The ARV of each T-shirt is \$20. Hundred (100) per month, seven hundred (700) runner up winners in total will each receive one (1) Salesforce-branded swag drink bottle ("Drink Bottle"). The ARV of each runner up prize is \$20. Total ARV of all prizes for the US and Canada is \$63,000. All currency listed in these Official Rules is in USD.
- 7. **PRIZE DETAILS AND CONDITIONS:** Certification voucher: (i) must be used within 12 months from the distribution date, unless notified otherwise; (ii) cannot be combined with any other certification discounts or vouchers; (iii) cannot be applied to past certification exams; and (iv) may be subject to additional terms and conditions. Winners must register for exams prior to voucher expiration date. Expiration date for the vouchers cannot be extended for any reason. Voucher cannot be combined with any other agreed discount or promotion. No refunds will be provided for exam fees paid prior to receiving the vouchers, on exam fees paid when there was a redeemable voucher, or for unused vouchers. Vouchers are non-transferable, not redeemable for cash, and eligible for use by the intended winning recipient only. Sponsor will determine any prize details not specified herein in its sole discretion. Prizes are not transferable, assignable or refundable and cannot be substituted for cash. Prizes must be accepted as awarded. Sponsor reserves the right to substitute prizes of equal or greater monetary value to the prizes if for any reason any prize cannot be awarded as contemplated in these Official Rules.

Sponsor is not responsible for lost or stolen prize elements. Prizes may be reported as income to a winner and the winner will be responsible for all taxes associated with the receipt of any prize. Winners may be required to complete required tax forms or other documents requested within the time period stipulated by Sponsor. Winners may be responsible for any costs and

expenses not listed herein. Winners will receive their prizes within thirty (30) days of the relevant prize date closing date unless notified otherwise. Sponsor reserves the right to cancel if the fairness of the Sweepstakes is compromised. Proof of identity, age and/or legal residence may be required to claim the prize. Failure to comply with any of the requirements set forth in the Official Rules may result in disqualification or forfeiture of the prize.

- 8. **WINNER NOTIFICATION AND ANNOUNCEMENT:** Sponsor will randomly select winners from among all eligible entries received during the applicable Monthly Entry Period. The potential winner(s) will be notified on or about five (5) days after the applicable Monthly Entry Period closes, via email. Sponsor will not be liable for any potential prize notification that is lost, intercepted, or not received by any potential winner for any reason. If a potential winner cannot be contacted within five (5) days after the first attempt to contact the winner, the Sponsor may select an alternate potential winner from the remaining eligible entries. If a potential winner is unable to accept the prize or any portion of the prize for any reason, Sponsor shall have no further obligation to such potential winner. There is a limit of one (1) first prize and one (1) runner up prize per entrant. You need not be present to win. To win a prize, entrants in Canada must correctly answer a mathematical skill-testing question to be administered in a manner to be determined by Sponsor. Although Sponsor attempts to ensure the integrity of the Sweepstakes, Sweepstakes Entities are not responsible for the actions of entrants or other individuals in connection with the Sweepstakes, including entrants' or other individuals' attempts to circumvent the Official Rules or otherwise interfere with the administration, security, fairness, integrity or proper conduct of the Sweepstakes. Sweepstakes Entities are not responsible for injury or damage to entrant's or to any other person's computer(s), wireless devices, other equipment or person(s), related to or resulting from participation in the Sweepstakes or downloading materials from or using any website. You are not a winner until your entry has been verified and you have complied with these Official Rules.
